4a (Code:) (Expenses \$ 581,413. including grants of \$ 0.) (Revenue \$ 262,151.) Youth Mediation served 169 youth with mediation and guided problem solving. More than 95% of youth participation resolved their conflict and improved behavior. 667 youth participated in conflict resolution skill building. More than 96% demonstrated a new skills in resolving conflict or helping peers resolve conflict. Community and Family Mediation served 1826 adults with mediation services. More than 85% resolved their dispute, and more than two-thirds of those reported that their agreements were being upheld 3 months later. Disputes mediated included neighborhood disputes, family conflicts, elder care issues, criminal complaints, disputes between friends, and Medicaid appeals. 132 adults participated in conflict resolution skills training. Many were trained as mediators. 98% reported that they learned a new skill that they will use in their home, work, or community. The Family Visitation Program helped keep 100% of participating families safe from abuse and neglect
